Blueriq Certification certifies and registers professionals based on their Blueriq knowledge and experience through practical audits

## Blueriq



Blueriq is a rule-based software platform, designed to create dynamic business solutions for organizations with knowledge-intensive processes.

It enables these organizations to react quickly and cost-effectively to changing circumstances and regulations.

Solutions in Blueriq are modeled and not programmed. This means no more time-consuming translations and handover moments between business, information analyst, and developer. This enables Blueriq customers to react quickly to *their* clients' needs, and they can focus on improving their operating results.

Applications created with Blueriq consist of several parts, namely user interactions, processes, and decisions. Blueriq supports all these functionalities in one suite and links them to existing peripheral systems.

## Competencies



Blueriq is not a code generating tool by which programmers can quickly develop screens, processes, and logic. Blueriq focusses on cutting away all translations and handover moments so that the person realizing the functionality is also the internal knowledge owner of the desired business process.

Blueriq does not claim that just any user without an affinity for IT can create rules that a computer will understand.

The use of Blueriq requires a specific skill set that you cannot obtain through standard IT training. Therefore, the Blueriq Academy has developed multi-day training sessions and multi-week courses to learn the basic skills.

Someone will only be a Blueriq specialist after gaining experience in multiple projects.

## Demand



More and more organizations that are applying Blueriq to create applications which support (part of) their knowledge-intensive work

require highly trained Blueriq specialists. How can we measure their level of competency?

Blueriq specialists are scarce in the market. People without any relevant experience may profile themselves as Blueriq experts while actual Blueriq specialists with vast experience are often overlooked.

Organizations often don't know if they are hiring the right people for their complex tasks. Therefore, they have requested an assessment tool which will indicate the level of quality of a Blueriq professional.

## Certification



Blueriq certification is the answer to this need from the market. The certification is based on knowledge and skills, which means that following a course is not sufficient.

There are three levels of the Blueriq certification: **Associate**, **Professional** and **Expert**. These certification levels apply to Business Engineers who work with Blueriq, as well as Software Developers who work on Blueriq.

## Proof



A Blueriq specialist who wants to be eligible for a specific certification level, needs to hand in a request with the Blueriq Certification

Commission. The detailed regulation is available and contains all the requirements necessary for the different roles and levels.

The burden of proof lies with the person requesting certification: he or she needs to prove that they meet the requirements for a specific certification level.

## Procedure



The procedure to qualify for a certain certification level is simple. Sending an email to the Blueriq Certification Commission will suffice

(certificering@blueriq.com).

In the email, the candidate can request to be certified for a certain level and role. The candidate also needs to establish that the requirements, as described in the regulations, have been fulfilled.

- For example, project experience can be shown by filling in all the defined requirements. Plus, a candidate needs to list one or more references such as from an architect or project leader. The Blueriq Commission will approach the referred person(s).
- Proof of following the courses is not necessary via the references as Blueriq Academy has a register through which that information can be verified. Naming the attended courses will suffice.
- Establishing the contribution to the Blueriq Community is possible by citing the how-to articles, questions, or papers that have been contributed.

The Blueriq Certification Commission will treat each application carefully and as quickly as possible. If the certification is granted, then the confirmation will be sent. If it is denied, then a statement will be provided.

## Exception



If a candidate believes themselves to be eligible without meeting *all* the requirements, then he or she may apply for an exception. Such an

exception will be evaluated carefully and thoroughly by the Blueriq Certification Commission.

## Specialization



The same applies in case of an additional annotation. A professional or expert who believes that they have *exceptional* expertise in a specific

Blueriq area can request an extra annotation. The burden of proof for such a specialization lies with the candidate for verification by the Blueriq Certification Commission. Examples of specializations are Dynamic Case Management, Documents, and/or Connectivity.

## Objection



When a candidate is under the impression that the Blueriq Certification Commission has not made the correct assessment

regarding his or her request for certification, then the candidate can object with the Supervision Commission (certificering@blueriq.com). This commission supervises the entire certification procedure and pays attention to the consistency, the speed of the decision making, and the explanations of the decisions.

The Supervision Commission will take the complaint into consideration and render the final verdict.

## Register



All individuals certified by Blueriq are listed in the public Blueriq register.

The register consists of the certified person's name, certification role, level, and, if available, a link to his/her LinkedIn profile.

## Blueriq knowledge



To conclude, the Blueriq certification covers both Blueriq tracks of knowledge of and expertise in Blueriq, from a business or a technical

viewpoint. Certification is not concerned with business or technical engineering. These last two competencies cover more than just Blueriq knowledge and are beyond the scope of the Blueriq certification.
